FOURTH STIPULATION OF THE PARTIES TO MODIFY CONSENT DECREE

WHEREAS, on February 5, 2010, the Court entered a Consent Decree in this matter, which set forth January 31, 2011, as the date by which EPA would issue various proposed rules and/or determinations, and November 30, 2011, as the date by which EPA would issue various final rules and/or determinations pursuant to 42 U.S.C. §§ 7411(b)(1)(B), 7412(d)(6), and 7412(f)(2); see Docket Entry 25, paragraphs 3-8;

WHEREAS, on January 25, 2011, the parties filed a stipulation of modification extending EPA's time to issue the proposed rules and/or determinations from January 31, 2011, to April 29, 2011; see Docket Entry 26;

WHEREAS, on April 27, 2011, the parties filed a second stipulation of modification extending EPA's time to issue the proposed rules and/or determinations from April 29, 2011, to July 28, 2011, and EPA's time to issue the final rules and/or determinations from November 30, 2011, to February 28, 2012; see Docket Entry 27;

WHEREAS, on July 28, 2011, EPA issued the proposed rules, see 76 Fed. Reg. 52,738; WHEREAS, on October 28, 2011, the parties filed a third stipulation of modification

extending EPA's time to issue the final rules and/or determinations from February 28, 2012, to

April 3, 2012; see Docket Entry 28;

WHEREAS, EPA received numerous comments on the proposed rules and requires

additional time to fully respond to the comments;

WHEREAS, the Consent Decree allows for modification of any provision of the Consent

Decree by written stipulation of the parties with notice to the Court, see Docket Entry 25,

paragraph 10(a);

NOW THEREFORE, the parties hereby stipulate as follows:

1. EPA is no longer required to perform the actions discussed in paragraphs 6-8 of

the Consent Decree by April 3, 2012.

2. Instead, EPA must perform such actions no later than April 17, 2012.

3. With the exception of the above-stated modifications, no other provision of the

Consent Decree has been modified.
